E 2: School of Choice Resolution for 2012-2013

The Resolution before you will allow students within the Oakland Schools ISD and its contiguous ISDs in grades Kindergarten through 12th grade the opportunity to attend the Madison District Public Schools, where seats are available, during the 2012-2013 school year. Once enrolled, these children may continue with the Madison District Public Schools through graduation.

MADISON DISTRICT PUBLIC SCHOOLS BOARD OF EDUCATION RESOLUTION

WHEREAS, the Madison District Public Schools desires to make certain of its schools, grades, and special programs as may from time to time be available for enrollment by nonresident students residing within the Oakland School Intermediate School District and its contiguous Intermediate School Districts, and to count same in membership pursuant to Section 105 and Section 105C of the State School Aid Act (MCL 388.1705 and 388.1705c), otherwise known as the Schools of Choice legislation, continuing with the 2012-2013 school year;

THEREFORE, BE IT RESOLVED, that the Madison District Public Schools shall make such schools, grades, and special programs as the Administration deems available for enrollment by nonresident students residing within the Oakland Schools Intermediate School District and its contiguous Intermediate School Districts, and count such pupils in membership pursuant to Section 105 and Section 105c of the State School Aid Act (MCL 388.1705 and 388.1705c), otherwise known as the Schools of Choice legislations, continuing with the 2012-2013 school year;

IT IS FURTHER RESOLVED, that the School District, through its Administration, will comply with all of the requirements set forth in MCL 388.1705 and 388.1705c for participation in Schools of Choice.

E 3: Adventure Day Care Varsity Club Lease

Adventure is a non-profit organization affiliated with Rainbow Child Care Center in Troy. Rainbow offers a variety of tuition-based pre-school and childcare programs in Oakland County. The district has been approached again by Rainbow/Adventure Earlier Care to continue partnership that would provide before and after-school child care for district students in grades K-6. This partnership would meet a need in the district without adding administrative costs or staff.

The lease agreement, developed by legal counsel from Lusk & Albertson, is enclosed. Highlights of the agreement include the provision that Adventure will have access to a classroom and use of the gym at the Halfman Elementary School, Edison Elementary School, and Wilkinson Middle School sites. Adventure will employ the child care staff, apply for state licenses, and handle all tuition payments. The agreement has been amended to pursue summer programs, child care during school breaks, or tuition-based pre-school programs.

Moved by Holder, supported by Rose that the Board of Education approves the Madison District Public Schools Lease Agreement with Adventure Early Care and Education Center (Varsity Club).

E 4: Food Service Partnership with Lamphere School District

A collaborative agreement with Lamphere Schools is proposed again for the following school year. The districts would share management services for the food service programs. Madison District would benefit from additional co-operative purchasing, increased use of federal funding, and reduce waste in food service. Additionally, the joint venture could result in grant-funded acquisition of point-of-sale terminals in schools to assist staff and students during the school lunch periods. The agreement for the 2012 – 2013 school year is the same as last year's with updated dates.

Moved by Holder, supported by Rose that the Board of Education approves the Cooperative Food Service Agreement in the amount of Forty-Seven Thousand Dollars (\$47,000.00) per year shall commence on the effective date and shall continue through June 29, 2013.
