PUBLIC HEARING MEETING

<u>3A – Ratification Resolution for the Bond Issue – Mr. Matt Hiser; Thrun Law Firm By resolution adopted on May 14, 2013 (the "Bond Resolution"), Madison District Public Schools, Oakland County, Michigan (the "Issuer"), authorized the issuance of not to exceed \$11,400,000, 2013 School building and Site Bonds (the "Bonds").</u>

The offer of the Underwriter as set forth in the bond purchase agreement dated June 13, 2013 (the "Bond Purchase Agreement") and the terms and conditions set forth therein, presented to the Superintendent to purchase the Bonds at a purchase price of \$11,304,694.00, which is the par value of the Bonds, plus an original issue premium of \$137,989.75, less the Underwriter's discount of \$57,000 and less the original issue discount of \$176,295.75, is hereby ratified and affirmed. The bonds shall be issued in the aggregate principal sum of \$11,400,000, designated to 2013 School Building and Site bonds (General Obligation – Unlimited Tax).

3E - Cash Flow Borrowing Resolution

RESOLUTION AUTHORIZING ISSUANCE OF NOTES IN ANTICIPATION OF STATE SCHOOL AID (AUGUST 2013 BORROWING THROUGH THE MICHIGAN FINANCE AUTHORITY)

The District is required to borrow money in order to maintain monthly cash flow.

- 1. Estimated 2013/2014 State Aid allocated or to be allocated for fiscal year ending June 30, 2014: \$8,688,196 (total amount estimated to be received from October 1, 2013 through August 31, 2014).
- 2. Amount of borrowing not to exceed: \$935,000.
- 3. Principal amount of Notes, bonds or other obligations subject to Section 148 of the Internal Revenue Code of 1986, as amended, relating to arbitrage and the rebate thereof, including but not limited to federally tax-exempt obligations, Qualified School Construction Bonds, and Qualified Zone Academy bonds, not including this borrowing, issued or to be issued during the 2013 calendar year: \$11,400,000 (include plans for voted or non-voted bonds, refunding bonds, additional state aid notes, tax anticipation notes, installment purchase agreements, and lease-purchase agreements.
- 4. The Notes shall be dated August 20, 2013 and shall mature on August 20, 2014, or such other date as determined by any Authorized Officer.
- 5. Purchase price: Not less than 97% of the principal amount of the Notes.
- 6. Five percent (5%) of estimated fiscal year 2013/2014 operating expenses: \$653,877.

Moved by Brecht, supported by Hohner that the Board of Education accepts the borrowing for the State Aid Note borrowing for the 2013/2014 fiscal year of not to exceed \$935,000.
