# 6A - Michigan High School Athletic Association (MHSAA) 2015-2016

Moved by Brecht, supported by Barndollar that the Board of Education adopts the Michigan High School Athletic Association Membership resolution for the year August 1, 2015 through July 31, 2016.

School district throughout Michigan have worked with Michigan High School Athletic Association (MHSAA) to establish a common set of rules for the orderly administration of an interscholastic athletic program which promotes academic integrity and competitive equity. Any school district considering participation in MHSAA tournaments and to benefit from MHSAA services must schedule on its Board of Education agenda the adoption of the Membership Resolution.

The resolution requires the listed schools in the district to follow the standardized rules and obligates the administration and Board of Education to enforce those rules.

As part of the responsibility for the supervision and control of interscholastic activities, each school district must establish a code of good sportsmanship for its athletics, coaches and spectators, an educational program to promote good sportsmanship, and a system of progressive discipline for failure to behave according to the code of good sportsmanship.

BE IT FURTHER RESOLVED that the respective Boards of Education must submit the advance preparation material included within this resolution to the MHSAA for approval.

BE IT FURTHER RESOLVED that the Madison District Public Schools Board of Education and Superintendent agree to the conditions and content of this resolution, and will work cooperatively for the success of the program and for the benefit of our students.

#### 6D - Macomb Christian Schools Shared Time Service Agreement

Moved by Marr, supported by Hohner that the Board of Education accepts the proposed Shared Time Service Agreement with Macomb Christian Schools, employing public school teachers to provide non-essential elective courses for the 2015-2016 school year

Shared time service agreements provide opportunities for public school districts and non-public schools to have cooperative agreements that assist both educational establishments with enhanced revenue. Under a shared-tie agreement, a public school district provides public school teachers to teach non-core subjects on site in a non-public or parochial school.

## Parameters for such an agreement are:

- 1. The non-public school must be registered with the Department of Education as a non-public school.
- 2. The shared-time instruction must be scheduled or occur during the regular school day of the public school district.
- 3. The instruction must be provided by an employee of the public school district.
- 4. The shared-time curricular offering must be available to full-time pupils in the minor's grade level or age group in the public school district during the regular school day at a public school site.
- 5. The curricular offering is restricted to non-essential elective courses, such as for example art, music, physical education, languages or AP courses.

If these requirements are satisfied, then the non-public school minor enrolled in the shared-time program is considered a part-time pupil for the purposes of the State School Aid Act.
