Presentation of the fiscal year 2015-16 proposed budget was presented by Oakland Schools Administration.

Not later than June 1 of each year, the board of each constituent district shall review the proposed intermediate school district budget, shall adopt a board resolution expressing it support for or disapproval of the proposed intermediate school district budget, and shall submit to the intermediate school board any specific objections and proposed change the constituent district board has to the budget.
